Data drives daily direction of LMH Public Safety staff, Private Security & Info sharing

Data supports Intel gathering, investigations, & formal law enforcement agency response

### LMH 5-Step Incident Report Procedure

### When does this procedure apply?

- ✓ When an LMH employee has observed/witnessed a crime, been involved in or told about a potential crime or serious safety and security incident, including but not limited to: (Deaths, injury, assaults, theft, break ins, vandalism, threats, disorderly conduct, trespassing, fire, weapon or drug reports, loss or damage of LMHA property including buildings, keys, phones, IDs, key fobs, and/or incidents of panic, concern, or alarm).
- ✓ Call Law Enforcement (911) or nonemergency number.
- ✓ Call Public Safety (419) 259-9404
- ✓ Call Supervisor
- ✓ Do LMH Incident Report
- ✓ Request Police Report





# Summary of recent progress

### **Public Safety Department:**

- ✓ Change on approach from Security Operations to Public Safety
- ✓ Public Safety Department expansion
- ✓ Mobile patrol enhancements (24/7 coverage Mon-Fri)
- ✓ Continental Armed Security patrol (weekends)
- ✓ Increased building Static Security services at four elderly designated sites from 7P-3A to 4P-7A, seven days a week.





# Summary of recent progress (cont.)

#### Public Safety Department:

- ✓ Camera System expansion and upgrades trained staff on usage
- ✓ Expanded and Upgraded Burglary and Keyless Access System, 4 pending
- ✓ Added OPOTA certified and highly trained LMH Mobile Patrol Officers and working towards an additional revised major expansion of Plan
- ✓ Enhanced Incident Report Database and After Hour Emergency Notification Call Tree to increase awareness and response
- ✓ Modified our procedures and reporting of information to ensure increased public safety and accountability
- ✓ Implementation of Hot Sheet, Safety Sweeps, Directed Patrols, Special Attentions
- ✓ Direct line of communication and sharing of Intel within LMH and in partnership with TPD, LCSO and community partners
- ✓ Hot Sheet, No Trespass list, Criminal Intel forwarded to Police & Security
- ✓ Safety First, a combined, proactive, teamwork partnership
- ✓ Safety is everyone's job, everyone has a part!
